Investment Profile

The composition of the Underlying of this structured product is managed **dynamically** and **discretionary** over the course of its term.

The basket invests primarily in cannabis stocks. The discretionary management of the underlying constituents is carried out by the investment manager, ENISO Partners AG. Investment decisions are based on quantitative and qualitative factors. Among others, liquidity and return ratios are taken into account.

Rebalancing The Investment Manager rebalances the portfolio composition based on its qualified evaluation of the market. The Rebalancing is based on net prices of the Underlying Components (average of the net prices of the Underlying Components converted into the basket currency by the Issuer). The rebalancing period may be prolonged by the Issuer due to limited tradability.

Issuer Risk

Obligations under these structured products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. The value of the structured product does not only depend on the performance of the Underlying and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this structured product.

Specific Product Risks
