Key Elements of the product

The ZKB Bonus Certificate on a Basket is an investment product which offers the Investor on the Redemption Date, under certain conditions, a Cash Amount equal to the Bonus Payment (CHF 1'190.00). In addition, the Investor has the opportunity to participate with 100.00% in the performance of the Basket above the Bonus Level.

If at least one of the Underlying Components' fixings has been trading at or below the respective Knock-out Level between Initial Fixing Date and Final Fixing Date, the Investor participates in the Underlying Component with the worst performance. In case the worst performing Underlying Component prices at or below the Bonus Level, the Investor will receive a number of Underlying Components according to Ratio. In case the worst performing Underlying Component prices higher on Final Fixing Date than the Bonus Payment, the corresponding Cash Amount will be paid.

Tax Issues

If none of the Underlying Components' fixings has been trading at or below the Knock-out Level during the product's lifespan, the performance of the Certificate will be at least 19.00% and above that level will be analogous to the performance of the Underlying, multiplied by the Participation Rate, see Scenario "Knock-out Level not touched". If at least one of the Underlying Components' fixings has been trading at or below the Knock-out Level, the Performance of the Certificate at redemption will be analogous to that of the Underlying Component with the worst performance, see Scenario "Knock-out Level touched". Therefore, the investor may suffer a partial or total loss. In this table, the assumption was made that Sandoz Group AG rs was the worst performing Underlying Component. 3. Material Risks for Investors

Issuer Risk

Obligations under this structured product constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. The value of the structured product not only depends on the performance of the Underlying and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this structured product.

Specific Product Risks
