"Coupon Dates"), in this case 9.192%. However, if the Final Fixing Value of at least one Underlying is below the Cap Level, the investor will receive a physical delivery of a number of Underlyings as defined in Ratio. The acquisition price of the delivered Underlyings is 90.00% of the Initial Fixing Value, which means that the performance of the Product is less negative than the performance of the Underlying. This negative performance is reduced by the guaranteed Coupons paid out during the term.

Issuer Risk
