Key elements of the product

This product is a combined investment instrument that essentially consists of a fixed income security and the sale of a down-and-in put option. This allows the investor to benefit from the current volatility of the Underlyings. An above-average return is achieved when prices fall slightly, stagnate or rise slightly. The Coupon of 10.75% p.a.\*\* is divided into a premium payment of 10.75% p.a.\*\* and an interest payment of 0.00% p.a.\*\*. Specific product risks
