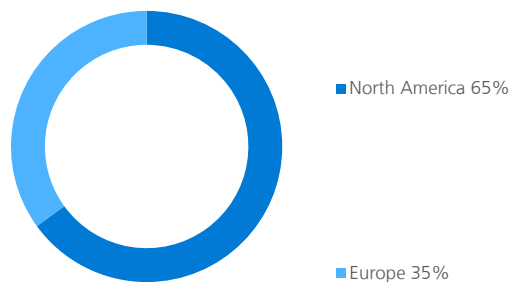

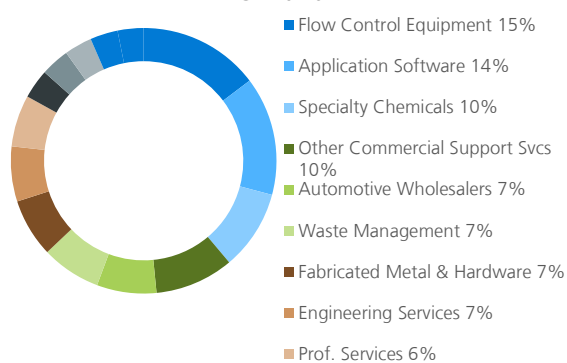
In brief
