Key Elements of the product

ZKB Capital Protection Note with Participation on worst of is a investment product which combines the purchase of a worst of "at the money" call option and a bond investment. At Maturity the investor participates in the positive performance of the worst performing Underlying. Additionally, a Minimum Redemption is guaranteed at Maturity, which is independent of the price behaviour of the Underlyings.

Taxes

The product is considered as transparent and IUP (Intérêt Unique Prédominant). The implied internal rate of return is subject to income tax for private investors with Swiss tax domicile at sale or maturity (IRR 0.00%** p.a., present value of bond part at issue 97.20%***) and is determined in compliance with the "modifizierte Differenzbesteuerung" tax rule based on the ESTV Bondfloor Pricing method. Any return derived from the option part qualifies as capital gain and is not subject to Swiss income tax for private investors with Swiss tax domicile.
