If the prices of the Underlyings do not close at or below the Knock-in Level on the Final Fixing Date, the performance of the ZKB Barrier Reverse Convertible Last Look on worst of with participation is given by the Coupons paid out over the lifetime (according to Coupon Payment Date(s)) gegeben, in this case 3.13%, see column "Knock-in Level untouched" plus any positive performance of the weighted Basket multiplied by the Participation rate. If on the Final Fixing Date the worst performing Underlying closes at or below the Knock-In Level, the performance of the ZKB Barrier Reverse Convertible Last Look on worst of with participation is determined by the performance of the worst Underlying and the 3.13% Coupons paid out over the lifetime (according to Coupon Payment Date(s)), plus any positive performance of the weighted Basket multiplied by the Participation rate. Modifications
