If the prices of the Underlyings do not close at or below the Knock-in Level on the Final Fixing Date, the performance of the Last Look ZKB Barrier Reverse Convertible on worst of will be at 6.60%, according to Coupon Payment Date(s). If on the Final Fixing Date the worst performing Underlying closes at or below the Knock-In Level, the investor receives a cash redemption in the amount of a number of Underlyings as defined in Ratio. Therefore, the investor may suffer a partial or total loss. The redemption of the Last Look ZKB Barrier Reverse Convertible on worst of will correspond to the Denomination minus the percentage performance of the worst performing Underlying. 6.60%

The Coupon will be paid out independently of the performance of the Underlyings.

The table above is valid at maturity only and is by no means meant as a price indication for this structured product throughout its lifetime. The price of this structured product depends on additional risk factors between the Initial Fixing Date and the Final Fixing Date. The price quoted on the secondary market can therefore deviate substantially from the above table. It was assumed, that Umicore s was the worst performing Underlying. This selection is just a representative example of the possible alternatives.

## 3. Material Risks for Investors

### Issuer Risk
