You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law. This is a structured product. The structured product is not a collective investment scheme as defined by the Collective Investment Schemes Act (CISA), nor is it subject to approval or supervision by the Swiss Financial Market Supervisory Authority (FINMA). Investors are also exposed to issuer risk.

Objectives The objective of this Product is to provide the Investor with an entitlement to returns in the form of Coupon Payments which are independent of the performance of the Underlyings (each an "Underlying" and together the "Underlyings", see table below). The Coupon Payments are equal to 9.44% p.a. of the Nominal Amount and are payable on the Coupon Payment Dates.

Repayment on maturity

If the investor holds the product until the repayment date, the maximum amount it may receive is the repayment amount plus the sum of the coupon amounts. The investor does not participate in the positive performance of the underlyings.

By investing in the product, the investor will receive a repayment amount equal to the nominal amount on the repayment date, provided that the underlyings perform favourably for the investor. If the underlyings perform unfavourably for the investor, the repayment amount may be lower. In detail:

- If the price of **each** underlying is quoted above its knock-in level at any time during the barrier observation period: the product is repaid in the amount of the nominal value.
- If the price of at least one underlying is quoted at or below its knock-in level at any time during the barrier observation period and
 - if the final fixing value of each underlying is quoted at or above its cap level: the product is repaid in the amount of the nominal value; or
 - if the final fixing value of at least one underlying is quoted below its cap level: the product is repaid at an amount equal to the nominal amount multiplied by the final fixing value of the worst-performing underlying divided by its Cap Level, i.e. the repayment amount is linked to the negative performance of the worst-performing underlying. In such cases, the repayment amount is usually lower than the amount you invested.

The product is currency hedged, i.e. the calculation of the repayment does not depend on exchange rate fluctuations between the product currency and the currency of the underlying (quanto style).

If the investor purchases the product during the term, he does not pay any additional accrued interest because this is included in the trading price ("dirty price").

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g., voting rights and dividends).

The risk and return profile of the product described above shall change if the product is sold before the repayment date.

Under the product terms and conditions, in case of an extraordinary event adjustments may be made to the product and the issuer may terminate the product early.
