You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law. This is a structured product. The structured product is not a collective investment scheme as defined by the Collective Investment Schemes Act (CISA), nor is it subject to approval or supervision by the Swiss Financial Market Supervisory Authority (FINMA). Investors are also exposed to issuer risk.

Objectives The objective of this Product is to provide the Investor with an entitlement to returns in the form of Coupon Payments which are independent of the performance of the Underlyings (each an "Underlying" and together the "Underlyings", see table below). The Coupon Payments are equal to 9.20% p.a. of the Nominal Amount and are payable on the Coupon Payment Dates.

Repayment on maturity

If the investor holds the product until the repayment date, the maximum amount it may receive is the repayment amount plus the sum of the coupon amounts. The investor does not participate in the positive performance of the underlyings.

By investing in the product, the investor will receive a repayment amount equal to the nominal amount on the repayment date, provided that the

- underlyings perform favourably for the investor. If the underlyings perform unfavourably for the investor, the repayment amount may be lower. In detail:
 If the price of **each** underlying is quoted above its knock-in level at any time during the barrier observation period: the product is repaid in the amount of the nominal value.
- If the price of at least one underlying is quoted at or below its knock-in level at any time during the barrier observation period and
- if the final fixing value of each underlying is quoted at or above its cap level: the product is repaid in the amount of the nominal value; or
 if the final fixing value of at least one underlying is quoted below its cap level: the product is repaid by delivering the underlying with the worst performance (between the initial fixing date and the final fixing date), i.e. the repayment is linked to the negative performance of the underlying with the worst performance. The number of underlyings to be delivered per nominal amount is defined according to the ratio. Remaining fractions are not delivered but settled in cash. In such a case, the sum of the value of the delivered underlying on the repayment date plus the settlement payments (for fractions of the underlying) and the coupon payments will generally be lower than the amount invested by the investor.

If the investor purchases the product during the term, he does not pay any additional accrued interest because this is included in the trading price ("dirty price").

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends). The risk and return profile of the product described above shall change if the product is sold before the repayment date.

How long should I hold it and can I take money out early?

Recommended holding period: 3/14/2025 (maturity) The objective of this product is to provide the investor with the entitlement described above under "1. What is this product?" provided the product is held to maturity.
