#### 1. Product Description

Participation Product/Tracker Certificate (1300, according to the Swiss Derivative Map provided by the Swiss Structured Products Association)

This product does not constitute a collective investment scheme within the meaning of the Swiss Federal Act on Collective Investment Schemes (CISA) and it is not subject to authorisation or supervision by FINMA. The issuer risk is borne by investors.

The composition of the Underlying of this structured product is managed **dynamically** and **discretionary** over the course of its term.

The Actively Managed Certificate (AMC) invests in an actively managed portfolio of Swiss equities that includes both growth stocks with high earnings potential and value stocks with attractive valuations and stable dividends. The focus is on individual stocks. In addition, (sector) ETFs may also be selected. The following criteria, among others, are decisive for inclusion in the Prime Swiss Shares Basket (not exhaustive): price-to-book ratio, price-to-earnings ratio, capital expenditure, price-to-earnings growth ratio, free cash flow, debt ratio, and dividend yield. The diversified portfolio comprises large-, mid- and small-cap companies from various sectors. Performance is monitored regularly and adjustments are made dynamically based on market conditions.

The rebalancing period may be prolonged by the Issuer due to limited tradability.

**Key Elements of the product** 

In terms of value, buying a ZKB Tracker Certificate Dynamic is equivalent to buying the Underlying less any Fees. A single, low-cost transaction gives investors the opportunity to participate fully in the performance of the Underlying. Dividend Payments of underlying components in the basket are paid out to the investor by means of Dividend reinvestment in the Underlying. Redemption is based on the weighted value of Underlying components on the Fixing Date.

#### Modifications
