If the Underlying has traded at or above the Knock-out Level during the lifetime of the product, the option part expires on that respective event. Then the Redemption at maturity will be 104.00% of the Denomination. If the Underlying closes below the Exercise Price on the Final Fixing Date, and has never traded at or above the Knock-out Level between Initial Fixing Date and Final Fixing Date, the Redemption will be 104.00% of the Denomination.
