Investment Profile

The composition of the Underlying of this structured product is managed **dynamically** and **discretionary** over the course of its term.

The AMC focuses on investments in ETFs on physical precious metals and stocks of companies in the mining sector, with a particular emphasis on gold and currency hedged in CHF. The goal is to benefit from the performance of leading precious metal producers as well as high-growth exploration companies. The certificate is actively managed to respond flexibly to market changes and commodity price fluctuations. The focus is on a careful selection of companies with solid fundamentals and stable production capacities, while considering sustainability criteria. By diversifying between physical precious metals and mining stocks, as well as further diversification within individual precious metals and within the mining sector, the risk is strategically spread, while simultaneously maximizing opportunities for attractive returns.

3. Material Risks for Investors

Issuer Risk

Obligations under these structured products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. The value of the structured product does not only depend on the performance of the Underlying and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this structured product.

Specific Product Risks

Structured products are complex financial instruments, which entail considerable risks and, accordingly, are only suitable for investors who have the requisite knowledge and experience and understand thoroughly the risks connected with an investment in these structured products and are capable of bearing the economic risks.

ZKB Tracker Certificate Dynamic is an investment product whose price fluctuates to the same degree as the Underlying less any Fees. Depending on price trends, the price of a ZKB Tracker Certificate Dynamic could fall below the Issue Price. The risk profile of the ZKB Tracker Certificate Dynamic corresponds to that of the Underlying. The ZKB Tracker Certificate Dynamic is denominated in CHF. If the investor's reference currency differs from the CHF, the investor bears the risk between the CHF and his reference currency.

Investments with regard to Emerging Markets are exposed to several risk factors especially political or economic risks.
