Key elements of the product

The Coupon of 10.00% p.a.** is divided into a premium payment of 8.2752% p.a.** and an interest payment of 1.7248% p.a.**. The interest payment is subject to income tax at the time of payment. The Swiss withholding tax is not levied. Issuer Risk
