If none of the Underlying Components' fixings has been trading at or below the Knock-out Level during the product's lifespan, the performance of the Certificate will be at least 14.50% and above that level will be analogous to the performance of the Underlying, multiplied by the Participation Rate, see Scenario ''Knock-out Level not touched''. If at least one of the Underlying Components' fixings has been trading at or below the Knock-out Level, the Performance of the Certificate at redemption will be analogous to that of the Underlying Component with the worst performance, see Scenario ''Knock-out Level touched''. Therefore, the investor may suffer a partial or total loss. In this table, the assumption was made that Kühne + Nagel Int rs was the worst performing Underlying Component. The selection is purely exemplary.

The above table is valid at maturity and is by no means meant as a price indication by the Issuer for this structured product throughout its lifetime. The value of this structured product depends on additional risk factors between the Initial Fixing Date and the Final Fixing Date. The price quoted on the secondary market can therefore deviate substantially from the table above.

3. Material Risks for Investors

Obligations under this structured product constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. The value of the structured product not only depends on the performance of the Underlying and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this structured product.

The loss potential of this certificate corresponds exactly to that of the Underlying Component with the worst performance if the Knock-out Level has been touched.
