This allows the investor to benefit from the current volatility of the Underlying. An above-average return is achieved when prices fall slightly, stagnate or rise slightly. Therefore, the investor may suffer a partial or total loss. The acquisition price of the delivered Underlyings is 95.00%** of the Initial Fixing Value, which means that the performance of the product is less negative than the performance of the Underlying.
