If none of the Underlying Components' Final Fixings is at or below the Knock-out Level on the Final Fixing Date, the performance of the Certificate will be at least 12.00% and above that level will be analogous to the performance of the Underlying, multiplied by the Participation Rate. If at least one of the Underlying Components' Final Fixing Levels is at or below the Knock-out Level, the Performance of the Certificate at redemption will be analogous to that of the Underlying Component with the worst performance.
