You are about to purchase a product that is not simple and may be difficult to understand.

### What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law. This is a structured product. The structured product is not a collective investment scheme as defined by the Collective Investment Schemes Act (CISA), nor is it subject to approval or supervision by the Swiss Financial Market Supervisory Authority (FINMA). Investors are also exposed to issuer risk.

Objectives The objective of this Product is to provide the Investor with an entitlement to returns in the form of a Coupon Payment which is independent of the performance of the Underlying (the "Underlying", see table below). The Coupon Payment is equal to 3.56% p.a. of the Nominal Amount and is payable on the Coupon Payment Date.

### **Repayment on maturity**

If the investor holds the product until the repayment date, the maximum amount it may receive is the repayment amount plus the sum of the coupon amounts. The investor does not participate in the positive performance of the underlying.

By investing in the product, the investor will receive a repayment amount equal to the nominal amount on the repayment date, provided that the underlying performs favourably for the investor. If the underlying performs unfavourably for the investor, the repayment amount may be lower. In detail:

If the final fixing value of the underlying is quoted at or above the cap level: the product is repaid in the amount of the nominal value; or
If the final fixing value of the underlying is below the cap level: the product is repaid by delivery of the underlying, i.e. the repayment is linked to the negative performance of the underlying. The number of underlyings to be delivered per nominal amount is defined according to the ratio. Remaining fractions are not delivered but settled in cash. In such a case, the sum of the value of the delivered underlying on the repayment date plus the settlement payments (for fractions of the underlying) and the coupon payments will generally be lower than the amount invested by the investor.

If the investor purchases the product during the term, he does not pay any additional accrued interest because this is included in the trading price ("dirty price").

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends). The risk and return profile of the product described above shall change if the product is sold before the repayment date.
