The possibility of an early redemption has been neglected in the above table.

If at maturity all Underlyings trade higher or equal to the Cap Level, the performance of the structured product will be at the over the lifetime paid out Coupon (according to Coupon Payment Date(s)) of 7.12%. If at maturity one or more Underlyings trade below the Cap Level, the investor will receive physical delivery of the Underlying with the worst relative performance (between Initial Fixing Date and Final Fixing Date). Therefore, the investor may suffer a partial or total loss. The cost price of the delivered Underlyings is at 80.00% of the Initial Fixing Value. As a result, the negative performance of the structured product is lower than the negative performance of the worst performing Underlying.

The table above is valid at maturity only and is by no means meant as a price indication for this structured product throughout its lifetime. The price of this structured product depends on additional risk factors between the Initial Fixing Date and the Final Fixing Date. The price quoted on the secondary market can therefore deviate substantially from the above table. It was assumed, that Chevron was the worst performing Underlying. This selection is just a representative example of the possible alternatives.

3. Material Risks for Investors

Issuer Risk
