Key elements of the product

Therefore, the investor may suffer a partial or total loss. The acquisition price of the delivered Underlyings is 88.00%** of the Initial Fixing Value (Cap Level), which means that the performance of the product is less negative than the performance of the Underlying. This negative performance is reduced by the guaranteed Coupons paid out during the term.
