The Coupon of 13.00% p.a.\*\* is divided into a premium payment of 13.00% p.a.\*\* and an interest payment of 0.00% p.a.\*\*. However, if the Final Fixing Value of at least one Underlying is below the Cap Level, the investor will receive a physical delivery of a number of Underlyings as defined in Ratio of the Underlying having the largest negative performance. Therefore, the investor may suffer a partial or total loss.
