Key elements of the product

The product pays out coupons on defined dates during the term. This product is a combined investment instrument that essentially consists of a fixed income security and the sale of a down-and-in put option. This allows the investor to benefit from the current volatility of the Underlyings. An above-average return is achieved when prices fall slightly, stagnate or rise slightly. The Coupon of 11.60% p.a.** is divided into a premium payment of 11.3435% p.a.** and an interest payment of 0.2565% p.a.**.
