Key Elements of the product

ZKB Capital Protection Note with Participation is an investment product which combines the purchase of an „at-the-money“ call option and a bond investment. The investor participates at the Participation Rate in any increase in the Underlying from the Exercise Price on. In addition, the Capital Protection guarantees the Minimum Redemption, which is independent of the price behaviour of the Underlying.

Taxes

The product is considered as transparent and IUP (Intérêt Unique Prédominant). The implied internal rate of return is subject to income tax for private investors with Swiss tax domicile at sale or maturity (IRR 2.05%** p.a., present value of bond part at issue 94.09%***) and is determined in compliance with the "modifizierte Differenzbesteuerung" tax rule based on the ESTV Bondfloor Pricing method. Issuer Risk

Obligations under this structured product constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer.
