
High-dividend stocks

An anchor in turbulent times

The selection includes both European and US equities, with a particular focus on Europe. The European stock market has proven resilient in the current market environment, especially given the 15% tariffs imposed by the US on European exports since August. Despite the ongoing trade conflict, the EuroStoxx 50 has gained almost 12% since the beginning of the year (total return, as of 3 September 2025). The addition of selected US companies with a stable dividend policy results in a well-diversified selection of equities that is broadly based across regions and sectors.
