The composition of the Underlying of this structured product is managed **dynamically** and **discretionary** over the course of its term.

The underlying constituents are selected by the investment manager on the basis of a proprietary model that takes quantitative and qualitative factors into account. Among other things, liquidity and return ratios as well as any country and geopolitical risks are taken into account. This approach forms the basis for the investment manager's qualified market assessment, from which investment decisions are derived.

Issuer Risk

Obligations under these structured products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. The value of the structured product does not only depend on the performance of the Underlying and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this structured product.

Specific Product Risks
