If the Knock-in Level is never touched between the Initial Fixing Date and Final Fixing Date, the performance of the ZKB Callable Barrier Reverse Convertible on worst of will equal the Coupon of 4.7000%**, cf. table under "Knock-in Level untouched", paid out during the term of the Structured Product according to Coupon Payment Dates.
