Investment Profile

The composition of the Underlying of this structured product is managed **dynamically** and **discretionary** over the course of its term.

The Tracker Certificate combines stocks that have been selected by ZKB Asset Management. The selected shares should benefit from the organically growing demand for more efficient products and services in the health care sector. They cover the entire value chain of health care. The universe ranges from companies that focus on productivity gains in research and development, to manufacturers of low-cost generic drugs, to companies that optimize information processing and supply chains, e.g. through the use of modern IT systems and online platforms.

In terms of value, buying a ZKB Tracker Certificate Dynamic is equivalent to buying the Underlying less any Fees. A single, low-cost transaction gives investors the opportunity to participate fully in the performance of the Underlying. Dividend Payments of underlying components in the basket are paid out to the investor by means of Dividend reinvestment in the Underlying. Redemption is based on the weighted value of Underlying components on the Fixing Date.

Taxes

The Issuer reports the taxable factors (change to previous year's value) divided in the components income and capital gain to the Swiss Federal Tax Administration on 31 October each year. Issuer Risk

Specific Product Risks

The risk profile of the ZKB Tracker Certificate Dynamic corresponds to that of the Underlying. The ZKB Tracker Certificate Dynamic is denominated in CHF. The investor bears all the risks in connection with a possible exchange rate risk between the product currency, the currency of the components of the Underlying, and his reference currency.
