If none of the Underlying Components' fixings has been trading at or below the Knock-out Level during the product's lifespan, the performance of the Certificate will be at least 19.00% and above that level will be analogous to the performance of the Underlying, multiplied by the Participation Rate, see Scenario ''Knock-out Level not touched''. If at least one of the Underlying Components' fixings has been trading at or below the Knock-out Level, the Performance of the Certificate at redemption will be analogous to that of the Underlying Component with the worst performance, see Scenario ''Knock-out Level touched''.
