Key elements of the product

The product pays out coupons on defined dates during the term. This product is a combined investment instrument that essentially consists of a fixed income security and the sale of a down-and-in put option. This allows the investor to benefit from the current volatility of the Underlyings. An above-average return is achieved when prices fall slightly, stagnate or rise slightly. If no Knock-in Event occurs, the investor receives a cash redemption in the amount of the Denomination. Tax aspects

The Coupon of 8.00% p.a.** is divided into a premium payment of 6.6463% p.a.** and an interest payment of 1.3537% p.a.**.
