The Coupon of 11.00% p.a.** is divided into a premium payment of 9.8665% p.a.** and an interest payment of 1.1335% p.a.**. The option premium part qualifies as capital gain and is not subject to Swiss income tax for private investors with Swiss tax domicile. The interest payment is subject to income tax at the time of payment. The Swiss withholding tax is not levied.
